MMTC Limited (MMTC) is a Government of India Enterprise (under the administrative control of Ministry of Commerce and Industry) having its Corporate Office at Core 1 Scope Complex,7 Lodi Road Institutional Area New Delhi-110 003 (hereinafter called 'MMTC'). MMTC is a Premier International Trading Organization of India with experience of handling international and domestic business for over five decades and has been handling import and export of various kinds of products and commodities.

MMTC is considering for appointment of a reputed well-established organization in Nepal and Bangladesh to act as an agent of MMTC for trade in various items especially COTTON to Nepal and Bangladesh. The agent is expected to have adequate experience in similar fields and is expected to liaise with all concerned Government Departments and Agencies in Nepal and Bangladesh. The engagement as agent shall be purely on contractual basis for an initial period of three year from the date of appointment which may be extended further for another one year at the sole discretion of MMTC based on the satisfactory performance of the agent.

MMTC Ltd desires to focus on the Export of COTTON from India.

Interested organizations in Nepal and Bangladesh are requested to send application furnishing complete details of their names, addresses, ownership structure, quantum of business being handled in COTTON experience in various fields of liasoning with private buyers / Government agencies in Nepal and Bangladesh as agent on behalf of overseas suppliers, etc.

The applications, in two part bidding system in the attached formats, must be addressed to Dr. A P Mishra, Additional General Manager, General Trade Division, MMTC of India Ltd., Core 1, 3nd Floor, Scope Complex, Lodi Road, New Delhi-110003 (India) and should

reach MMTC latest by 1500 hrs IST on 14.03.2019. Bids should be accompanied by Demand Draft favouring 'MMTC Limited' for INR Rs 25,000/ (Rupees Twenty Five Thousand) (non refundable and non interest bearing) or USD 355 towards processing fees.

Pre-Qualification Bids / Envelope-I shall be opened at 1600 hrs on 14.03.2019 in MMTC's office in the presence of bidder's representatives desirous to be present. Price Bids / Envelope II of only the technically qualifying Bidders shall be opened after evaluation of pre qualification bid.

Successful bidder shall be required to furnish a performance guarantee bond either in the form of demand draft payable at New Delhi or in the form of Bank Guarantee (BG) amounting to INR Rs 1,00,000 (Rupees One Lakh). The format of BG shall be provided once the contract is awarded. The Performance Guarantee bond is to be kept valid for a minimum period of 36 months after expiry of the contract. Successful bidder shall also undertake to work exclusively for MMTC in COTTON without handling similar assignment for any other Principal.

Bidder will be informed time, date and venue of opening the price bid at least one working day prior to the opening of price bid.

MMTC reserves the right to reject the bids without giving any reasons thereof. Incomplete applications are liable to be rejected. All expression of interest documents will become the property of MMTC upon submission. Where the applicant believes that information provided in response to this EOI should be kept confidential or disclosure of this information would unreasonably affect the applicant's business, notice is to be given at the time of delivery of such information or documents by marking such information 'confidential'. As far as possible and practicable, MMTC will give effect to applicant's stated wishes and requests for access to such information will be barred under normal circumstances. MMTC is not obliged to accept or respond to applicant requests for information on the status and progress of EOI evaluation process.

MMTC is not bound contractually or in any other way to any applicant to this Expression of Interest. MMTC is not liable for any cost or compensation in relation to this consideration of this Expression of Interest.

All disputes or differences whatsoever arising between the parties out of or relating to the construction, meaning and operation or effect of this contract or the breach thereof shall be settled by arbitration in accordance with the Rules of Arbitration of the Indian Council of Arbitration and the award made in pursuance thereof shall be binding on the parties.
