- 4. In case of movement by container rakes the sequencing for loading and despatch shall be on the basis of receipt of full payment by MMTC. A normal rake load will comprise of 80 containers (in case of containerised movement)
- 5. If rake less than normal (80 containers) is placed then the quantity shall be loaded accordingly and balance amount of the payment shall be refunded.
- 6. Quantities will be sold subject to re-confirmation by MMTC.
- 7. Payment can be deposited by the buyer at any of the MMTC locations mentioned below. The payment to include 100% value of material + GST and freight as and wherever applicable.
