- 1. 100% payment in advance. Delivery by road also permitted.
 - a) For booking upto 3,500 MT: 100% advance payment.
 - b) For booking upto 10,000 MT: 100% advance for one rake plus 15% advance payment as security for balance quantity only on basic price of the material. The payment for full quantity booked to be made within validity of Price Circular. After that interest @16% per p.a. will be charged. Proportionate adjustment of security advance is permitted.
- 2. If delivery through railway rakes: invoicing by NINL will be done on actual weight of the wagons. However, freight will be charged as per RR on tare basis of wagon.
- 3. The above prices are exclusive of excise duty, sales tax, freight and other statutory duties/taxes etc.
- 4. Quantities will be sold subject to re-confirmation by MMTC.
