MMTC shall collect security/c form, form-27 (c) from the party in favour of NINL. Security @6% separately, shall be given in the form of cash/ bank guarantee.
- 4. Sale will be made on first cum first serve basis on receipt of 100% payment in MMTC account.
- 5. The decision of MMTC regarding allocation of material shall be final and binding without any prejudice.
- 6. All supplies / deliveries are subject to availability of stock.
- 7. Material will be despatched against 100% value of the material along with freight, wherever applicable.

- 13. The Liquid Oxygen, Liquid Nitrogen and Liquid Argon will be sold on metric tons basis and will be delivered through tankers only.
- 14. The weight of materials delivered on ex-plant basis shall be as per NINL weighment scale.
