Jayalakshmi Enterprise, a partnership firm having their registered office Flat No F Alsa deer Park 101 Velachery Road, Guindy, Chennai- 600 032 were associated with MMTC Limited for export of Granite under MOU dated 20.05.1993. The party has willfully defaulted in honouring their payment obligation to MMTC. An arbitration award was also received in favour of MMTC which was challenged by Jayalakshmi Enterprise before Madras High Court. Hon'ble Madras High Court upheld the award in MMTC's favour. Vide Letter dated 27.01.2007, MMTC's Advocate had called upon the party and their partners to pay the sum awarded by Hon'ble Arbitrator and the notice was received back undelivered with the endorsement "left/no such addressee". In view of above, it has been decided to blacklist/debar Jayalakshmi Enterprise alongwith their partners and restraint them from any further imports, exports and domestic trade with MMTC till clearance of all the dues.

In view of the failure of the party to honour the Court directions and repay dues as per Court orders, MMTC has prohibited all its offices from entering into any further transactions with the party.
