Also it may be noted that this empanelment of fabricators/manufacturers of fabriator will be valid for two years from the date of empanelment and may be extended as per MMTC Discretion. Further MMTC may invite fresh Price bid from such empanelled manufacturers from time to time for fabrication of Gold & Silver bars/ coins of different denominations as required by MMTC during the time of empanelment.

1.1 BACKGROUND

MMTC Limited (hereinafter referred to as MMTC) was set up in 1963 under the Ministry of Commerce; Government of India and is engaged in international and domestic trading of commodities/products like minerals, metals, precious metals, fertilizers, coal & hydrocarbons, agro commodities and general trade. On recognizing the lack of quality products in the Precious Metal Retail market, MMTC Limited, one of India's largest international trading companies, diversified in to retail business of precious metals to cater to the customers' demand of Gold Jewellery, Gold & Silver Medallions / Coins of various denominations and various other products with zero compromise on quality.

In order to achieve its above vision and in view of the increasing demand of the market, MMTC intends to empanel technically competent, experienced and financially sound Manufacturing / fabricating agencies, having their own adequate infrastructure, machinery with valid licenses etc as required under the statute. The services of Manufacturing / fabricating agencies will be utilized for fabrication of Gold & Silver Coins (Silver Medallions), Bars of different denominations and any other requirements that may arise involving its precious Metal Product line on offer in the market. MMTC will empanel such eligible firms for a period of two years from the date of empanelment.

1.2. SCOPE OF WORK

The manufacturer/fabricator shall, as and when referred by MMTC, render the following services:-

- a) Manufacturing / Fabrication of primarily Silver Coins / Medallions / bars of various denominations ranging from 5GM to 1000 GM denomination from raw silver supplied by MMTC and Bars. Primarily in round, oval, square and rectangular shapes with positive tolerance in terms of weight and Purity.
- b) Manufacturing / Fabrication of any other Coins / Medallions or of desired specification or shape from the raw silver or Gold (999 fineness or any other fineness as required) handed over by MMTC to the fabricator / manufacturer, which MMTC so desires as per its requirement.
- c) All stock issues and receipts shall be ex- MMTC Jhandewallan office complex.
- d) Acceptance of all fabricated medallions/bars lots submitted by the fabricator is subject to the strict quality check that MMTC conducts as per its internal policy to maintain the quality it promises in the market.

1.3 MINIMUM ELIGIBLITY CRITERIA:

The Manufacturing / fabricating agencies (herein after referred as bidder) should fulfill the following criteria:

- 1. Should be legal entity registered in India
- **2.** Must have its own Medallion Fabrication / Manufacturing unit with adequate infrastructure and machinery. (Relevant document proof to be submitted; Eg.Previous records of job orders received)
- **3.** <u>Minimum</u> 3 years experience in Coins/Medallions fabrication / Manufacturing.
- **4.** <u>Minimum</u> Rs. 1 Crore annual turnover during any of these last five years ie) 2016-17,2017-18,2018-19, 2019- 20,2020-21.
- **5.** Should not have been blacklisted by any Central/ State Government/ Public Sector Undertaking . An undertaking in this regard is required to be submitted.
- **6.** Bidder should not be involved in any litigation that may put the stock of MMTC Limited at risk or compromise the performance/delivery of services as required under the scope of work & Terms & Conditions of Empanelment and in execution as per agreement.
- 7. Bidder must have a valid PAN and GST certificate number.
- **8.** Bidder must be compliant of all statutory requirement in terms of tax & GST rules.

2.2) TERMS & GENERAL CONDITIONS:

- Bidder/fabricator/manufacturer (hereinafter referred to as bidder) must have his own manufacturing / fabricating unit for fabrication of Silver Medallions / Coins.
- 2. Bidder must have a Valid PAN No issued by the IT department in favour of the agency and has to furnish Copy of the IT returns for the Last three years.
- 3. Bidder/s shall have to submit an EMD of Rs. 50,000/- in the form of a Demand Draft drawn from any nationalized bank in favor of MMTC Limited, payable at New Delhi.
- 4. Successful empanelled bidders shall enter in to an aggrement with MMTC for manufacturing/fabrication of Gold/Silver medallions/coins/bars of various denominations. The job order/ work order placed by MMTC on empanelled bidders will be guided by the Terms of the said agreement.
- 5. MMTC reserves the right to remove any such empanelled bidder from the empanelment list along with forfeiture of EMD as well as Performance Guarantee amount, if the service provided by the bidder is found to be unsatisfactory or if the information provided for empanelment is proved to be false or in the event of a breach of contract by the agency.
- 6. MMTC reserves the right to reject any application that does not fit or comply to its requirement or by assigning any other reason as per its policy.
- 7. The bidder will be required to submit a minimum of Rs. 25 Lakhs of security in the form of Bank Guarantee or equal to 110 % of the raw material value (whichever is higher) supplied to the bidder by MMTC for fabrication of medallions/bars as per job order. No interest will be paid on cash deposited if any by the empanelled bidder as security.
- 8. The Security amount in the form of BG/cash deposit shall become refundable only when the bidder has supplied the full quantity of medallions/bars placed vide the job orders ,and no metal balance after reconciliation physical metal balance account with MMTC.
- 9. MMTC shall place on the bidder order (s) for fabrication of medallions / coins and bars out of silver or gold, which it so requires, along with necessary specifications and samples. The raw Silver or Gold in appropriate fineness required for the completion of job order shall be handed over by MMTC to the bidder against the bank Guarantee/security submitted by the bidder.

- 10. The raw material required will be handed over by MMTC ex-Jhandewalan from our Medallion Unit. The bidder has to arrange for lifting the raw material to their godown or factory for the fabrication of medallions at their own expense and shall take adequate transit insurance to cover all incidental risk in logistics.
- 11. The raw Silver or Gold so handed over to the empanelled bidder by MMTC shall be property/inventory of MMTC and shall remain in trust with the bidder. Any financial damages due to physical loss of the raw material or damages in any other form due to any unforeseen circumstance while in trust of the bidder will be recovered from the bidder or by invoking the bank guarantee submitted by the bidder.
- 12.Bidder shall manufacture and supply medallions / coins /bars as ordered / required by MMTC, out of the raw material supplied to the fabricator from MMTC.
- 13. Medallions / Bars / Coins supplied shall be as per the specification / purity provided by MMTC. Any minor deviation shall result in rejection of the lot supplied at the total cost and expenses of the bidder. No Claim of what so ever nature, against the rejected lot, shall be accepted by MMTC in any case.
- 14. No advance payment in any form will be made for any of the work assigned by MMTC . The e-payments shall be released by MMTC against the bills received from the bidder after having completed the job to the satisfaction of MMTC.
- 15. The workmanship of the coins /Medallions and Bars fabricated shall be of high and good quality.
- 16.MMTC shall send its authorized officials to inspect the work-in-progress while its job order is under production for fabrication of medallion or pending submission of an existing job order.
- 17.Bidder shall render a statement of the raw Gold & Silver on monthly basis, which is supplied by MMTC and also give quarterly certificate of metal balance or as and when requested by MMTC.

18. The bidder shall follow input and output norms as under:-

- 19. The medallions/bars fabricated along with the raw metal balance, if any, shall be delivered at bidder own cost, by the bidder in the medallion unit at our MMTC Jhandawalan office.
- 20. The supplies shall be made by the bidder within time prescribed by MMTC. The bidder accepts the time of supply specified in the order placed on him by MMTC through job order or e-mail or through request in writing. All such documents, email will be binding on the bidder and shall form integral part of this agreement. In case, the bidder fails to deliver the items within time mentioned in the order, he shall be liable to pay damages to MMTC which shall be @ 1% of the fabrication charges of the job order per week or subject to maximum of 20% of the job order value.
- 21.MMTC will be entitled to cancel the order and on such cancellation the bidder shall return the silver and gold and the medallions/bars fabricated and the remaining raw material back to MMTC.
- 22.bidder unequivocally accepts to undertake any job order placed and accepts that he shall not be entitled to any claim of damages and/or any other relief from MMTC for any damages occurred due to handling and in the operation of fabrication at the bidders' premises and in transit.
- 23.MMTC reserves the right to accept only those coins/medallions/bars submitted by the bidder, which comply with the design, specifications prescribed by MMTC and are of the purity as ordered by MMTC. The decision of MMTC in this respect shall be final. The bidder shall be paid only for those medallions/bars, which have been accepted by MMTC.
- 24.Bidder will undertake to reimburse and indemnify MMTC of all damages incurred by MMTC in case any third party to whom any item fabricated by the Fabricator is sold /supplied by MMTC is found to be defective and/or have purity less than what has been declared.
- 25. The bidder undertakes not to use MMTC trade mark or designs or dies for fabrication of Coins / Medallions/ Bars for own use or for any other firm/ Company /third party including individual etc, both during the tenancy and after expiry of this agreement. In case the fabricator is found to be indulging in any such activity, MMTC reserves the right to forfeit the PG / FDR / invoke the BG lying with MMTC. In addition MMTC reserves the right to take legal action and claim suitable compensation.
- 26. On termination / expiry of the fabrication arrangement the dies / mould lying with the empanelled bidder pertaining to MMTC will need to be deposited back with MMTC.
- 27. The empanelment of eligible bidders shall be done based on the Criteria for evaluation as defined at Section 1.4 of this EOI document.
- 28. Sample Coin / Medallion/Bars submitted with the tender (Refer Section 3) shall become the property of MMTC Ltd as a bench mark commitment by the bidder. Any deviation to the bench mark commitment while supplying the fabricated

Silver and Gold Coins /Medallions/Bars by the empanelled bidder shall be rejected at the total risk, cost and expenses of the bidder. This will also amount to breach of contract and could cause termination of the empanelement or as decided by the Competent Authority of MMTC Limited.

- 29.MMTC Limited reserves the right in its sole and absolute discretion to change or modify the terms & conditions. In case of change in any terms & condition based on the dynamics of the market the same will be communicated to the bidder and bidder hereby abides to comply with the same.
- 30. **ARBITRATION:** Any dispute or difference whatsoever arising between the parties out of or relating to the construction, meaning, scope, operation or effect of this agreement or the validity or the breach thereof shall be settled by arbitration by a sole arbitrator in accordance with Rules of Arbitration of the Indian Council of Arbitration and the award made in pursuance thereof shall be binding on the parties.
