**1. EMD**

An EMD amount of **Rs.1000/-** has to be enclosed along with the bid. The EMD shall be in the form of **Demand Draft** favoring “**MMTC LIMITED**”. The EMD of all unsuccessful bidders shall be returned back to them within 2 working days after the bids are opened.

**2. Inspection**

The vault will be available for inspection from **23rd July 2021 to 29th July 2021** between 10:30AM and 5.00 PM (only on working days – Monday to Friday) in MMTC's regional office at **No.6 Esplanade, Chennai House, 2nd Floor, Chennai - 600108**. No counter conditions or relaxations of conditions mentioned in tender will be accepted.

**3. Submission of offer/tender**

Highest offer duly filled up for the vault listed for sale shall be considered. **4. Opening of the Bid**

Bids will be opened **on 30th July, 2021 at 3:30 pm**. Price bid in respect of valid bidders and who have submitted D. D. towards EMD shall be opened. The bidder or their authorized representative may witness the tender opening.

**5. Acceptance**

MMTC Limited reserves the right either to accept / reject any offer at its discretion. After offers are opened, sale may be postponed or cancelled by MMTC Limited at its discretion if the bids are found unsuitable. MMTC also reserves the right to further negotiate with highest bidder. Highest successful bidder will have to deposit **25% of the final bid by way of DD / RTGS on the next working day** of opening/finalizing the tender. The balance payment as decided after negotiation shall be paid within **five working days** failing which the EMD and 25% of the bid shall be forfeited. ## **6. Tax :**

All applicable Taxes will be levied by MMTC Limited and Payable by the bidder over and above the bid price.

## **7. Delivery.**

The Cost on account of taking delivery of vault / shifting of vault / transportation etc., will be to the account of the successful bidder. Upon effecting full payment, the Successful bidder should take delivery of vault from MMTC Premises within five working days of handing over of allotment letter. In case delivery of vault is not taken within five days, penalty will be charged at the rate of Rs. 200/- per day upto 3 days. Thereafter, MMTC Limited at its discretion may cancel the sale and shall forfeit the entire amount deposited by the bidder including EMD. No complaint will be entertained in this matter and the vault will be disposed through fresh tender.

## **8. Arbitration :**

All dispute or differences whatsoever arising between the parties out of or relating to the construction, meaning and operation or effect of this contract or the breach thereof shall be settled by arbitration in accordance with the rules of Arbitration of the Indian Council of Arbitration and governed by Arbitration and conciliation Act, 1996 and amendments thereof. The venue of the arbitration will be at Chennai. The award made in pursuance thereof shall be binding on the parties.

## **9.Fraud Prevention Policy.**
