<u> Part – I</u>

GENERAL INSTRUCTIONS TO TENDERERS & SPECIAL CONDITIONS

ELIGIBILITY CRITERIA:

- A. Only those /contractors who have minimum 3 years' experience in the field of undertaking similar works viz for construction of compound wall with Galvanized Iron (GI) sheet and during the last 3 years (works completed on or after May 2020), executed successfully similar works individually costing as under will be considered eligible:
 - a) Two works Contract costing not less than Rs. 1 Lakhs each. OR
 - b) One work Contract costing not less than Rs. 2 Lakhs. AND

c) Have a minimum yearly turnover of Rs. 10 Lakhs during the last three (3) years supported by audited financial statements. <u>AND</u>

- B. Bidders should submit the following documents in respect of their eligibility:
 - a) Copies of detailed work order indicating scope and value of works.
 - b) Completion certificate for the qualifying works.
 - c) List of completed works with all the details.
 - d) Financial statement for the previous three financial year in support of annual turnover of minimum Rs. 10 Lakhs per year.
- C. **Non eligibility**: Bidder's whose contracts have been terminated/foreclosed by any department/company/firm during the last 2 years due to non-fulfilment of contractual obligation are not eligible to bid. The bidder should provide a declaration to this effect in writing separately as per **"Annexure F**".
- D. Only bidders who qualify as above will be eligible to tender for the work. A tender submitted by a firm who is found to be not satisfying the aforementioned criteria's will be liable for rejection.

DOCUMENT REQUIREMENTS: Each bidder shall submit following documents including the tender document. Tender submitted without any of the following document will be disqualified from the bid process:

- a. Notice Inviting Tender (NIT) duly signed by the bidder.
- b. Terms of Contract duly signed by the bidder.
- c. Copy of Permanent Account Number (PAN) issued by Income Tax Authorities.
- d. Certified copies of annual turn-over details for the last three years (balance sheet, IT returns) certified by C.A signed and sealed by tenderer
- e. Proof of valid registration with statutory authorities under GST & certificate thereof.
- f. In addition to above, the documents required as mentioned in the eligibility criteria.
- g. Legal Status of the company.
- h. Experience certificate issued by the companies for previous three years as per requirement of eligibility criteria.
- i. Proof of payment towards Earnest Money Deposit (Interest free) of Rs. 25,000/- (Rupees Twenty Five Thousand only) made by way of e-payment to MMTC Limited, Mumbai to be deposited/credited to our State Bank of India, Fort, Mumbai-400001 A/c No. 40034579997, IFSC SBIN0000300.
- j. Bidder should submit latest Income Tax annual returns of past 3 years.
- k. In case the party is registered with Ministry of MSME/its authorized agencies, the e-bidder is required to submit, registration certificate. The MSMEs parties will be eligible for the benefits as

applicable to them under MSMEs Act, 2006.

- l. Certificate under Shop and Establishment Act.
- m. Copy of valid Labour License to be submitted, if required.
- n. Registration certificate under NSIC/MSME, if any.
- o. Details of Bank account e.g. Name of Bank, Name of branch, type of A/c, IFSC Code, Branch Code.
- p. Declaration on stamp paper Rs.100/- duly attested by Notary Public in respect of not blacklisted by any department.

For participation in tender, proof of payment made to MMTC account is to be enclosed with the Technical Bid. The EMD of successful e-bidder shall be adjusted against Contract Performance Security Deposit on award of work.

Under procurement policy for Micro & Small Enterprises (MSEs) order' 2012 as notified by the Government of India, Ministry of Micro Small & Medium Enterprises, New Delhi vide Gazette Notification dated 23/03/2012, the parties registered with MSEs or its authorized agencies such as NSIC etc., are exempted to deposit the participation fee and EMD.

E-bids in **TWO SEPARATE FORMS** comprising **TECHNICAL BID (annexure-A)** with prescribed EMD & documents and **PRICE BID (annexure-B)** in prescribed format duly filled in and signed by the in both bids and submit through e-mode.

Bidders are required to enclosed the Documents with (TECHNICAL BID) as stipulated in clause 2 – **'Document requirement'.** Please note that all the required documents form a part of TECHNICAL BID. The tender submitted without the requisite tender fee, EMD and all the documents are liable to be summarily rejected.

The e-TECHNICAL BIDs shall be opened on schedule date/ time in MMTC office in presence of the bidders, who wish to be present on the date of opening.

The e-TECHNICAL BIDS shall be scrutinized/ verified by a Committee in terms of the tender/scope of the work and subsequently the PRICE **BIDS of only technically qualified bidders** shall be opened within a week. The date will be intimated to the technically qualified bidders.

PRICE EVALUATION CRITERIA: Price Evaluation of bids shall be done on basis of lowest price quoted by the bidder for complete work as per scope of work. Amendment to Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 vide Government of India Gazette Notification S.O. 5670 (E) dated 09th November 2018 by Ministry of Micro, Small & Medium Enterprises, and Govt. of India shall be applicable.

CURRENCY OF QUOTE: Bidders have to quote in INR only.

BID VALIDITY: Tender submitted by bidders shall remain valid for acceptance for a period of 75 days (as per GeM) from the date of opening of the tender/Techno Commercial Bid.

All pages of the offer must be signed/ sealed by the bidder.

The bid with any additional condition's condition/ deviations by the bidders, whatsoever shall be rejected.

The bidder shall quote the rates in English Language and International numerals. These rates shall be entered in figures as well as in words. In case of difference in rates between words and figures, the rates mentioned in words shall be treated as valid and final.

All entries in the tender shall be typed/written in ink. Erasers and over writing are not permitted and such tenders may be liable for rejection. The tenderer shall duly attest all cancellations and insertions.

The Earnest Money Deposit may be forfeited in the event of (i) If a bidder withdraws its tender during the period of tender's validity. And/or (ii) In case of successful bidder failing to commence the work, as required.

The Earnest Money Deposit of unsuccessful bidders shall be returned within reasonable time without any interest. The interest free Earnest Money Deposit of successful bidder shall be retained and converted as part of interest free Security performance deposit. The Security Deposit shall be refunded only after successful completion of contract and after adjustment of dues, recoveries, etc, if any.

If the successful bidder deliberately gives wrong information in tender, MMTC reserves the right to reject such tender at any stage or to cancel the contract, if awarded and forfeit the Earnest Money Deposit/Security deposit/ any other moneys due without prejudice of taking legal resource.

MMTC do not bind itself to accept the lowest or any tender and reserves the right to reject any or all the Tenders in full or part, without assigning any reasons thereof.

The successful bidder shall require to submit an Affidavit as per **annexure-D** and enter into a contract as per **annexure-C**.

The terms and conditions of the e-bid documents and all other correspondence, shall also form an integral part of the agreement to be entered into with successful bidder of tender.

PERFORMANCE GUARANTEE: The successful bidder shall submit a performance guarantee amount equivalent to 20% percent of the contract value through e-mode to the MMTC Limited, Mumbai. The Contract Performance Guarantee amount shall be released to Successful bidder upon satisfactory completion of work.

No claim shall be admissible against MMTC in respect of interest on Performance Guarantee regardless at the time of the release.

The Performance Guarantee amount shall be forfeited by MMTC in the event of any breach or negligence or for non-acceptance of any condition of contract or for unsatisfactory performance or for non-execution of work by successful bidder.

The successful bidder shall be directly responsible for the discipline and proper conduct of all machine operators, labours, etc. and shall ensure systems, procedures, rules and regulations for the purpose and prevent misbehaviour/indiscipline/non-adherence to the instructions of MMTC. In such an event, successful bidder shall be intimated of such act for taking remedial action including arrangements to replace the defaulting person(s) without any loss of time.

The successful bidder shall indemnify MMTC and keep MMTC indemnified against any claims or liability whatsoever from any authority under the labour laws or any other laws. The successful bidder undertakes to fully indemnify and at all times keep MMTC fully indemnified and harmless against any actions, sanctions, claims, losses, damages, demands, expenses or costs whatsoever that MMTC may incur and/ or suffer on account of any fault on the part of the successful bidder in the discharge of his obligations as per

terms and conditions of the tender, including but not limited to the claims on account of any other circumstance's incidental to the scope of work. In case, successful bidder fails/has failed to give the services as per terms of the tender, scope of work, terms and condition, subsequent contract undertaking or if MMTC at its sole discretion considers that the successful bidder is not in a position to fulfil its obligations, MMTC may without being obliged to do so and without prejudice to any of its other rights and remedies, repudiate this agreement and procure the scope of work done at the cost and risk of the successful bidder from alternative sources. The provisions of the aforementioned indemnity clause shall survive the termination of this contract.

The compensation, connected expenses and legal disputes between the firm and staff deployed and any unforeseen casualty shall be borne/paid/settled by the successful bidder and MMTC Limited, in no way shall be party to the disputes and shall have no liability on this account. It will be responsibility of the successful bidder to provide wages as per minimum wages notified by Central Government under the Minimum Wages Act, 1948 and follow other statutory obligations.

PAYMENT TERMS: Payment for construction of compound wall with Galvanized Iron (GI) sheet shall be release by MMTC on successful completion of construction of compound wall and upon handing over the site to MMTC against the bill of supply as per the rates finalised and communicated through work order issued by MMTC based on acceptance of bid.

RIGHT TO TERMINATE THE PROCESS - MMTC reserves the right to cancel the contract placed on the selected e-bidder and recover expenditure incurred by MMTC under the following circumstances: -

The successful bidder commits breach of any of the terms and conditions of the bid. The bidder goes into liquidation, voluntarily or otherwise.

If the successful bidder fails to complete the assignment/deliver the services as agreed herein as per the time lines and guidelines prescribed in this e-tender and subsequent Contract and the extension, if any allowed, it will be a breach of contract. MMTC reserves its right to cancel the contract in the event of delay and withheld/forfeit amount from the pending bills as damages for delay.

In the event of the successful bidder being adjudged insolvent or having a receiver appointed for it by a court or any other order under the Insolvency Act made against them or in case of a successful bidder passing any resolution or making of any order for winding up, whether voluntary or otherwise, or in the event of the successful bidder failing to comply with any of the conditions herein specified, MMTC shall have the power to terminate the contract on with 30 days' notice period.

In case successful bidder fails to deliver the services as stipulated in the contract, MMTC reserve the right to procure the same or similar services from alternate sources at the risk, cost and responsibility of the successful bidder. In such event EMD and Performance Security Deposit shall forfeit.

After award of the contract, if the successful bidder does not perform satisfactorily or delays execution of the contract, MMTC reserves the right to get the contract for remaining period executed by another party of its choice by giving one month notice for the same. In this event, the successful e-bidder is bound to make the good the additional expenditure, which MMTC may have to incur for the same. This clause is applicable, if for any reason, the contract is cancelled/terminated.

MMTC reserves the right to recover any dues payable by the successful bidder from any amount

outstanding to the credit of the successful bidder including from the pending bills and/or invoking the contract performance security deposit under this contract.

The notice so issued at the address of Contractor, mentioned herein shall be construed as received by the Contractor.

CONSEQUENCES OF TERMINATION:

In the event of termination of the contract due to any cause whatsoever, MMTC shall be entitled to impose any such obligations and conditions and issue any clarification as may be necessary to ensure an efficient transition and effective business continuity of the Service(s)/scope of work intended under the present tender which the successful bidder shall be obliged to comply with and take all available steps to minimize loss resulting from the termination/breach, and further allow the next successor to take over the obligations of the erstwhile successful bidder in relation to the execution/continued execution of the scope of the contract.

Nothing herein shall restrict the right of MMTC to invoke the guarantee (if any) and other guarantees, securities furnished, enforce Indemnity of successful bidder and pursue such other rights and/or remedies / legal recourse that may be available to MMTC under law or otherwise against successful bidder. The notice issued to the bidder on given address of the contract shall be continued as served even if the bidder has shifted without intimation to MMTC.

The termination hereof shall not affect any accrued right or liability of either Party nor affect the operation of the provisions of the contract that are expressly or by implication intended to come into or continue in force on or after such termination.

RELATIONSHIP BETWEEN THE PARTIES:

Nothing in the subsequent contract constitutes any fiduciary relationship between MMTC and successful Bidder/ Bidder 's Team or any relationship of employer employee, principal and agent, or partnership, between the MMTC and Successful Bidder.

No Party has any authority to bind the other Party in any manner whatsoever except as agreed under the terms of the subsequent Contract.

MMTC will not be under any obligation to the subsequent successful bidder except as agreed under the terms of the Contract.

ASSIGNMENT: The Successful Bidder shall not sub-contract, transfer, assign or otherwise part with the tender/contract or any part thereof, either directly or indirectly or transfer any interest, right, benefit or obligation under this contract.

WAIVER: The failure of either party to enforce or to exercise at any time or for any period, any term of or any right pursuant to this tender/contract shall not be construed as a waiver of any such term or right and shall in no way affect that party's right later to enforce or exercise it.

<u>GOVERNING LAW:</u> This contract shall be governed in accordance with the laws of India.

CONTINUANCE OF THE CONTRACT: Notwithstanding the fact that settlement of dispute(s) (if any) under arbitration may be pending, the parties hereto shall continue to be governed by and perform the work in accordance with the provisions under the Scope of Work to ensure continuity of operations and in such case EMD and Performance Security Guarantee will be withheld by MMTC till the settlement.

PUBLICITY: The successful e-bidder shall not make or permit to be made a public announcement or media release about any aspect of this Contract unless the MMTC first gives its written consent to do so.

INDEMNITY: The successful bidder undertakes to fully indemnify and at all times keep MMTC fully indemnified and harmless against any actions, sanctions, claims, losses, damages, demands, expenses or costs thrifts whatsoever that MMTC may incur and / or suffer on account of any fault on the part of the successful bidder in discharge of the obligation under this contract, including but not limited to the claims on account of any other circumstances' incidental to the scope of work. In case, successful bidder fails / has failed to give the services as agreed in the tender, scope of work, terms and condition, subsequent contract, undertaking or if MMTC at its sole discretion considers that the successful bidder is not in a position to fulfil its obligations, MMTC may without being obliged to do so and without prejudice to any of its other rights and remedies, repudiate this contract and procure the scope of work done at the cost and risk of the successful bidder from alternative sources. The provisions of the aforementioned indemnity clause shall survive the termination of the contract.

CONFIDENTIALITY AND SAFEGUARD OF PROPERTY: MMTC and Successful bidder respectively agree to keep in confidence, and not to disclose or use for its own respective benefit or for the benefit of any third party (except as may be required for the performance of services under this contract or as may be required by law), any information, documents, or materials that are reasonably considered confidential regarding each other's products, business, customers, MMTCs, suppliers, or methods of operation; provided, however, that such obligation of confidentiality will not extend to anything in the public domain or that was in the possession of either party prior to disclosure. MMTC and Successful bidder will take reasonable precautions to safeguard property of the other entrusted to it.

ENTIRE CONTRACT:

The terms and conditions laid down in this Tender, subsequent contract and all annexures thereto as also the Proposal and any attachments/annexes thereto shall be read in consonance with and form an integral part of the contract.

The subsequent draft contract constitutes the whole of the contract between the Parties relating to the matters dealt with herein along with any allied exchange correspondence and, save to the extent otherwise provided herein, no undertaking, representation, term or condition relating to the subject matter of this contract not incorporated in this contract shall not be binding on either of the Parties.

All provisions and the various clauses of subsequent contract/agreement are, notwithstanding the manner in which they have been grouped together or linked grammatically, severable from each other. Any provision or clause of subsequent contract which is or becomes unenforceable in any jurisdiction, whether due to voidness, invalidity, illegality, unlawfulness or for any other reason whatever, shall, in such jurisdiction only and only to the extent that it is so unenforceable, be treated as pro non scripto and the remaining provisions and clauses of subsequent contract shall remain of full force and effect. The Parties declare that it is their intention that contract would be executed without such unenforceable provision if they were aware of such unenforceability at the time of execution hereof.

<u>SIGNING OF TENDER</u>: Each and every page of the tender document to be signed and stamped in acceptance of the terms and conditions. Individual signing the tender or other documents connected with contract must specify whether he/she signs as:

A 'sole proprietor' of the concern or constituted attorney of such sole proprietor.

A partner of the firm, if it be a partnership firm, in which case he must have authority to execute contracts on behalf of the firm and to refer to arbitration disputes concerning the business of the partnership either by virtue of the partnership contract or by a power of attorney duly executed by the partners of the firm.

In case of partnership firms; a copy of the partnership deed or general power of attorney duly attested by a Notary Public should be furnished on stamped paper duly sworn or affirmed by all the

partners admitting execution of the partnership contract or the general power of attorney. The attested copy of the certificate of registration of firm should also be enclosed along with the tender.

In the case of partnership firms, where no authority to refer disputes concerning the business of partnership firm has been conferred on any partner, the tender and all other related documents must be signed by all partners of the firm.

A person signing the tender form or any documents forming part of the tender on behalf of another person, he/she should have an authority to bind such other person and if, on enquiry it appears that the persons so signing had no authority to do so, MMTC may, without prejudice, cancel the contract and hold the signatory liable for all costs, consequences and damages under the civil and criminal remedies available.

Director or a principal officer duly authorized by the Board or Directors of the Company, if it is a company.

COMPLIANCE WITH LAWS:

The successful Bidder shall comply with the laws in force in India in the course of performing the Agreement / Contract:

During the performance of the contract, the successful bidder shall at his own cost and initiative fully comply with all applicable laws of the land and with all applicable by-laws, labour laws, rules, regulations and any other provisions having the force of law, made or promulgated or deemed to be made or promulgated by any Government, Government agency, or Department, Municipal board, government or other regulatory or authorized body of persons and shall provide all certificates to MMTC of compliance therewith as may be required by such applicable law, by-laws, labour laws and rules, regulations, orders. The successful bidder shall assume full responsibility for the payment of all contributions and payroll taxes, as to its workforce, servants or agents engaged in the performance of the work specified in the tender / agreement documents

If during the tenure of contract stipulated herein, successful bidder may find violating any laws, norms attributed & applicable from this tender / subsequent agreement / contract, in such event, the successful bidder will be solely liable to face the consequence of violation, in as much, the successful bidder may keep MMTC safe and indemnified from any of the losses / risk which may occasioned by non-performing any statutory rules, regulation or law in force.

ARBITRATION: Any dispute or difference whatsoever arising between the parties out of or relating to the construction, meaning, scope, operation or effect of this contract/Tender or the validity or the breach thereof shall be settled by arbitration by a sole arbitrator to be nominated by CMD of MMTC Ltd. The provisions of Arbitration and Conciliation Act, 1996 and subsequent amendments thereof shall apply to such arbitration proceedings. The venue/seat of Arbitration shall be at Mumbai.

FORCE MAJEURE: If at any time during the existence of this contract either party is unable to perform in whole or in part any obligations under this contract because of war, hostility, military operations, civil commotion, sabotage, quarantine, restrictions, acts of God and acts of Government (including but not restricted to prohibitions of exports and imports), fires, floods, explosions, epidemics, strikes, or any other labour trouble, embargoes, then the date of fulfilment of any obligations engagement shall be postponed during the time when such circumstances are operative.

If operation of such circumstances exceeds **three months**, either party shall have the right to refuse further performance of the contract in which case neither party shall have the right to claim eventual damages. The party which is unable to fulfill its obligations under the present contract shall, within 15 days of occurrence of any of the causes mentioned in this clause inform the other party of the existence or termination of the circumstances preventing the performance of the contract. Notwithstanding this,

provisions relating to indemnity, confidentiality survive termination of the agreement.

SIGNING OF CONTRACT: Contract per annexure 'C' shall be signed within ten days from the date of receipt of e-payment in MMTC Ltd., account for interest free security deposit.

FRAUD PREVENTION POLICY: The Contractor shall be required to certify that they would adhere to the Fraud Prevention Policy of MMTC and shall not indulge themselves or allow other (working in MMTC) to indulge in fraudulent activities and that they would immediately appraise the organization of the fraud/suspected fraud as soon as it comes to their notice. Concealment of facts regarding their involvement in fraudulent activities in connection with the business transactions(s) of MMTC is liable to be treated as crime and dealt with by the procedures of MMTC, as applicable from time to time.

HOLIDAY LISTING: Notwithstanding anything contained in this agreement, MMTC's policy for holiday listing of an agency mutatis mutandis applies to this agreement and in the event the agency(s)/Contractor while discharging its obligations under the agreement or otherwise come(s) within the ambit of the said policy, MMTC at its sole discretion reserves the right to suspend /discontinue dealing or taken any curative measures with the agency(s)/contractor in accordance with the policy in force.

UNDERTAKING: The successful bidder should give an undertaking on non-judicial stamp paper stating they will not carry any anti-national activity in the premises.

The successful bidder must comply with all terms and conditions contained in the entire tender document.

Part -II

SCOPE OF WORK:

26. <u>CONFIDENTIALITY AND SAFEGUARD OF PROPERTY</u>: MMTC and Contractor respectively agree to keep in confidence, and not to disclose or use for its own respective benefit or for the benefit of any third party (except as may be required for the performance of services under this contract or as may be required by law), any information, documents, or materials that are reasonably considered confidential regarding each other's products, business, customers, MMTCs, suppliers, or methods of operation; provided, however, that such obligation of confidentiality will not extend to anything in the public domain or that was in the possession of either party prior to disclosure. MMTC and Contractor will take reasonable precautions to safeguard property of the other entrusted to it.

27. ENTIRE CONTRACT:

- a. The terms and conditions laid down in laid down in Tender document and in this contract and all annexures thereto as also the Proposal and any attachments/annexes thereto shall be read in consonance with and form an integral part of the contract.
- b. Contract between the Parties relating to the matters dealt with herein along with any allied exchange correspondence and, save to the extent otherwise provided herein, no undertaking, representation, term or condition relating to the subject matter of this contract not incorporated in this contract shall not be binding on either of the Parties.
- c. All provisions and the various clauses of contract are, notwithstanding the manner in which they have been grouped together or linked grammatically, severable from each other. Any provision or clause of this contract which is or becomes unenforceable in any jurisdiction, whether due to voidness, invalidity, illegality, unlawfulness or for any other reason whatever, shall, in such jurisdiction only and only to the extent that it is so unenforceable, be treated as pro non scripto and the remaining provisions and clauses of this contract shall remain of full force and effect.
- d. The Parties to this contract, declare that it is their intention that contract would be executed without such unenforceable provision if they were aware of such unenforceability at the time of execution hereof.

- 28. **SEVERANCE:** In the event any provision of the Contract is held to be invalid or unenforceable under the applicable law, the remaining provisions of this contract shall remain in full force and effect.
- 29. **GOVERNING LANGUAGE:** This contract is written in English language; such language versions of this contract shall govern its interpretation. All correspondence and other documents pertaining to this contract that are exchanged by parties to this contract shall be written in English language only.

30. COMPLIANCE WITH LAWS:

- a. The Contractor shall comply with the laws in force in India in the course of performing this contract
- b. During the performance of the contract, the Contractor shall at his own cost and initiative fully comply with all applicable laws of the land and with all applicable by-laws, labour laws, rules, regulations and any other provisions having the force of law, made or promulgated or deemed to be made or promulgated by any Government, Government agency, or Department, Municipal board, government or other regulatory or authorized body of persons and shall provide all certificates to MMTC of compliance therewith as may be required by such applicable law, by-laws, labour laws and rules, regulations, orders.
- c. The Contractor shall assume full responsibility for the payment of all contributions and payroll taxes, as to its workforce, servants or agents engaged in the performance of the work specified in the tender documents and in this contract.
- d. If during the tenure of contract stipulated herein, Contractor found violating any laws, norms attributed & applicable from this contract, in such event, the Contractor will be solely liable to face the consequence of violation, in as much, the Contractor may keep MMTC safe and indemnified from any of the losses / risk which may occasioned by non-performing any statutory rules, regulation or law in force.
- 31. **ARBITRATION:** Any dispute or difference whatsoever arising between the parties out of or relating to the construction, meaning, scope, operation or effect of this contract or the validity or the breach thereof shall be settled by arbitration by a sole arbitrator to be nominated by CMD of MMTC Ltd. The provisions of Arbitration and Conciliation Act, 1996 and subsequent amendments thereof shall apply to such arbitration proceedings. The venue/seat of Arbitration shall be at Mumbai.
- 32. **FORCE MAJEURE:** If at any time during the existence of this agreement either party is unable to perform in whole or in part any obligations under this contract because of war, hostility, military operations, civil commotion, sabotage, quarantine, restrictions, acts of God and acts of Government (including but not restricted to prohibitions of exports and imports), fires, floods, explosions, epidemics, strikes, or any other labour trouble, embargoes, then the date of fulfilment of any obligations engagement shall be postponed during the time when such circumstances are operative.

If operation of such circumstances exceeds **three months**, either party shall have the right to refuse further performance of the contract in which case neither party shall have the right to claim eventual damages. The party which is unable to fulfil its obligations under the present contract shall, within 15 days of occurrence of any of the causes mentioned in this clause inform the other party of the existence or termination of the circumstances preventing the performance of the contract. Notwithstanding this, provisions relating to indemnity, confidentiality survive termination of the contract.

- 33. **MODIFICATION /AMENDMENT:** Any modification / amendment of the contract shall be in writing and signed by an authorized representative of each party, which shall form the part of the existing contract.
- 34. The tender No._____ dt.____ shall form part and parcel of this contract. In case of dispute with regards to meaning of them the decision of MMTC shall be binding.

SCOPE OF WORK

Scope of work under this tender is to construction and complete the boundary wall of 18 feet hight from the plot ground level with MS I beams, MS square pipes, Gate I beam around the plot with proper entry gate covering with Galvanised Iron (GI) profile sheet of 0.4 MM thickness with proper screw fitting. All the required material i .e. MS I beams, MS square pipes, Gate I beam, GI sheet of 0.4 MM, screw, etc. shall be supplied by the successful bidder to construct and complete the boundary wall with proper entry gate, etc.

Description and details of material required to be supplied on approximate basis is given below:
