Invoicing will be done on actual weight as finalized by NINL in motion weighbridge / NINL static weighbridge as the case may be. In case of delivery by rail, freight will be charged as per RR on the basis of chargeable weight. Any other charges from Railways such as Demurrage, Punitive charges etc. shall be to Buyer's account.**
2. The above prices are exclusive of GST, Railway/Road Freight and Other Statutory duties/levies/taxes etc.
3. Sale shall be made on first-come-first-serve basis. Railway indent or loading of trucks will be based on the sequence of payment received. Payment should be made till 1630 Hrs on 16 Nov., 2018.
4. Material will be dispatched against receipt of 100% value of the material along with freight, wherever applicable.
5. The decision of MMTC regarding allocation of material shall be final and binding without any prejudice.
6. All supplies/deliveries are subject to availability of stock.
7. MMTC reserves the right to withdraw/review this price circular at any time without assigning any reason.
8. The price shall remain firm till completion of delivery of entire quantity against the Delivery Order, irrespective of the price prevailing on the day of actual delivery.

10. MMTC will receive all payments.
