**E- Tender for Processing/ Milling of Imported Toor Whole**

MMTC Ltd., a Govt. Of India Enterprise have imported pulses under government account to ease out the supply crunch and stabilize the price of pulses in domestic market. Accordingly, Bids are invited for appointment of PROCESSORS/MILLERS from well established processors/millers for processing of imported Toor Whole Malawi/Mozambique origin. Interested parties can submit their bids for processing/milling of imported Toor whole of Malawi/Mozambique origin.

1. **Tentative quantity to be Processed/Milled:** 395 MTs lying at CWC warehouse, Vashi, Navi Mumbai & 105 MT lying at CWC Chennai.

2. **Job Work:**

- Lifting of 395 Mts of Imported Toor Whole from CWC Vashi & 105 MT at CWC Chennai and free transportation to their Mill (transportation costs, and loading/unloading expenses to be borne by the tenderer).
- Conversion of Toor whole (Malawi/Mozambique origin) pulses into Toor dal of sava quality in 50 kg bags.

4. **Processing period:-** Toor whole to be processed during the month of May, 2016 onwards and as per the requirement of MMTC Ltd.

5. **Eligibility Criteria:-**

- Miller/processor should have own running mill/processing unit with a valid licence and experience of minimum 3 years.

- b) Processor/Miller must have sound financial background with good turnover and should submit Solvency certificate for Rs 10 lakhs from their bankers along with copies of Income Tax returns and Balance sheets for the last 3 years.
- c) Milling capacity in 120 MTs per day (enclose certificate)
- d) Processor/Miller shall have performed satisfactorily against earlier orders issued/awarded by any Indian PSUs/State Governments.
- e) The Processor/Miller shall process the given pulses as per the specifications prescribed in the tender. MMTC reserves the right to accept or reject any/all tenders and cancel the bid any time.
- f) MMTC shall neither be liable for any such action nor be under any obligation to inform the bidders, the ground for such action.
- g) EMD of 2% of the cost of the material (approx.Rs.90,000 PMT) to be submitted along with application. Only such applicants who submit EMD in time shall be finally considered
- h) Successful bids whose application is accepted by MMTC for consideration will be required to give performance guarantee (BG Format as per MMTC) as per clause 9.

6. **Submission of bids:-** Filled-up signed bids and tenders should be submitted in prescribed TENDER FORMS in TWO BID SYSTEM:-

Bidder to submit an EMD of 2% of cost of the material (Rs.90,000 PMT) in the form of Demand draft. Demand Draft is to be furnished to MMTC before 1500 Hrs IST on 06.05.2016

The price bids, if any received in the tender shall be opened at 1600 hrs. IST on same day i.e. 06.05.2016. Bidders or their authorized representatives may attend the opening of the tender, if they wish to do so.

- a) Each page/document must be signed by the Bidder.
- b) The Buyer reserves the exclusive right to increase, decrease or split the quantity tendered.
- c) Letter(s) of acceptance will be issued by Fax or E-mail or Registered Post/ Courier to the successful bidder(s) and/or his/their Agents(s) in India within the validity of offer.

Offer(s) incomplete or deficient, received late and/or not accompanied by valid EMD may be rejected at the discretion of the Buyer.

Any litigation and/or arbitration between MMTC and the bidders, summons or any other legal process served on the local agent, shall be admitted and held as valid as if served upon the principal/bidder

MMTC reserves the right to reject and / or accept all or any offers including the lowest offer without assigning any reasons.

**7. Other terms:-**

- a) Processor/Miller will have to guarantee the realization of Toor dal to be processed from Toor Whole of Malawi/Mozambique origin lying at the MMTC's warehouses imported by MMTC.
- b) All expenses shall be borne by the processor/miller in respect of taking delivery of Toor whole, transportation to mill, processing/milling, sampling, bagging in 50 kgs, which shall have branding & other relevant details including statutory markings and labeling requirements such as FSSAI etc.
- c) Miller to quote prices including the cost of packing material. Millers to give outturn bid (Annexure-B) for Sava quality only. The bid will be evaluated on the outturn.
- d) Processed dal is to be supplied for PDS, and hence the quality and quantity should strictly meet requirement as per AGMARK/FSSAI standards.
- e) MMTC's personnel and/or Surveyors appointed by MMTC may supervise the milling process as and when required and miller shall allow such supervision access by MMTC's personnel and/or Surveyors.
- f) The Miller/Processor should have cleaning equipments at pre-milling stage, adequate space to store Toor Whole in scientific manner, adequate infrastructure for conversion of Toor Whole into Toor Dal and for transportation.
- g) Dal should be processed in premises maintained in hygienic conditions that shall be open to inspection at any time as mentioned in point (d) above.
- h) Loading charges into trucks of processed dal at processing point will also be borne by Processor.
- i) One month free storage time at miller's premises should also be provided in outturn bid.
- j) Based on performance, MMTC reserves the right for continuation of scheme as proposed or to cancel the scheme, subject to the policy by Govt. of India or any other factor arising in future. In such an event, whatever left over Toor Whole stocks retained with the miller without conversion should be handed over/delivered back to the corporation in good condition.
- k) It is the responsibility of the miller to maintain the stocks of Toor Whole supplied by MMTC always in an separate identifiable space and infest free condition. MMTC is empowered to undertake quality control checks during the storage of Toor Whole by the Miller during the period of the contract. There should be no comingling of stocks & finished Toor Dal with other stocks in processor/miller premises.
- l) Millers shall be responsible in regard to quantity and quality of Toor Whole while transportation and storage.
- m) MMTC may at any time at its sole discretion blacklist Processors/Millers in case their performance is not found to be satisfactory.

**8. Validity of Offer:-** The offer made by the bidders shall be valid for 1 year and further extendable for another 1year. The Tenderer should not quote any other date of validity for their offer. Offer of bidder shall be valid for one year from the date of registration and it can be further renewed/extended at sole discretion of MMTC subject to fulfillment of conditions of contract successfully at the time of such renewal/extension.

**9. Performance Guarantee:** - The Successful bidder whose offer will be accepted by MMTC, will be required to submit Bank Guarantee/ Security Deposit. The value of BG will be calculated at the approx. cost of the Toor Whole of Rs 90,000 PMT multiplied by the quantity proposed to be lifted in one lot. **The validity of the BG will be for a period of one year and 3 months additional for claim period.** Millers offering to mill higher volumes may offer Bank Guarantee for higher values.

In the event of non-fulfillment of contractual term or breach of contract, the performance guarantee will be forfeited.

10. The details of the contracts of similar or higher size entered into and executed by the processor/miller in the current year and previous year shall be furnished.
11. **By products:-** By-products shall be retained by the miller. No other charges or cost or expenses or milling charges, packing cost, transportation cost of Toor whole etc. shall be paid to the miller.
12. **Duration of delivery:-** As the stock is required urgently to ensure uninterrupted supply under PDS, MMTC is very keen in getting stock within the stipulated time.
  - a) The Miller should commence supply of Dal Ex- Mill within 3 working days from the date of lifting of Toor whole, at least @ 50 MT per day.
  - b) No extension of time will be considered beyond the time schedule. Hence, the delivery schedule prescribed by MMTC should be kept at any cost.
13. **Penalty on default/extension of time:** The entire ordered quantity of Toor Whole should be lifted from MMTC's warehouses at Mumbai for its conversion into dal and the dal should be delivered ex-mill within the stipulated time. No extension of time will be considered. But in exceptional circumstances and if it is sufficiently proved that the delay in processing is due to the circumstances beyond the control of the bidder, extension of time will be granted at the discretion of MMTC.

A suitable penalty in addition to forfeiture of Performance Bank Guarantee will be imposed in the event of failure to transport the Toor Whole and deliver the Toor Dal in time at the discretion of MMTC Ltd.

14. **Execution of Agreement:** - The successful bidder would be given material against the 100% Bank Guarantee in parcels/lots. The successful bidder shall execute an agreement for the transportation and conversion of Toor Whole into Dal as per the terms and conditions on a stamp paper of value as prescribed in law within 3 days from the remittance of security deposit. In the event of failure to execute the agreement within the time prescribed, the EMD/Security deposit remitted by the tenderer shall be forfeited. Further, MMTC reserves the right to recover the consequential loss, if any sustained from such bidders on account of transportation/purchase made through re-tender or in other manners and the bidders are bound to pay the same on demand.
1. **Volume of Work:** Presently MMTC offers a tentative quantity of 395 MTs lying at CWC warehouse, Vashi, Navi Mumbai & 105 MT lying at CWC Chennai. MMTC shall not guarantee any volume of work in future during the currency of the agreement. The mere mention of the item of work or the quantities mentioned in the tender shall not itself confer any right to the Tenderer to demand that the entire work should necessarily or exclusively be entrusted to him. MMTC reserves the right to appoint one or more other Millers and distribute the work among them during the currency of the agreement at its unfettered discretion in any manner that it may decide and no claim for compensation shall lie against the Corporation by reasons whatsoever of such divisions of work or variation of the quantity. The decision of the MMTC in this matter shall be final and binding on the Miller.

## 2. QUALITY SPECIFICATIONS:-

The quality of Toor Dal should be as per the specification mentioned below:-

- a) Consist of husked and split seeds of pulses (cajanus cajan) with polished finish;
- b) Be sweet, clean, wholesome, uniform in size, shape, colour and in sound merchantable conditions;

- c) Be free from living and dead insects, fungus infestation, added colouring matter, mould, obnoxious smell, discoloration;
- d) Be free from rodent hair and excreta;

Maximum limits of tolerance (percent by weight) FSSAI regulations or the specifications of the Whole Tur delivered for milling, whichever is lower

Sl. No.	Specification	Tolerance limit
1.	Moisture	Not more than 14 % by weight.
2.	Foreign matter (Extraneous matter)	Not more than 1 % by weight of which not more than 0.25% by weight shall be mineral matter and not more than 0.10% by weight shall be impurities of animal origin.
3.	Other edible grains	Not more than 0.5% by weight.
4.	Damaged grains	Not more than 5% by weight.
5.	Weeviled grains	Not more than 3% by count.
6.	Uric acid	Not more than 100 mg per kg.
7.	Aflatoxin	Not more than 30 micrograms per kilogram.

Provided that the total foreign matter, other edible grains and damaged grains shall not exceed 6% by weight.

- e) Stocks having refractions in excess of tolerance limit stands summarily rejected. MMTC's decision will be final and binding on the miller.
- f) At the time of delivery of stocks by the miller, the stocks will be subjected to quality check by the surveyor (**SGS**) appointed by MMTC at the loading locations. Samples will be drawn as per the procedure of MMTC in the presence of the miller or their authorized representative. **SGS inspection certificate at the loading point shall be the basis for acceptance of processed material.** In the event of supply of stocks not conforming to the specification as indicated in the specification above, such stocks are liable for rejection.
- g) As the moisture content of the grain is bound to vary depending upon the atmospheric temperature and humidity, no appeal will be entertained for the moisture content recorded. Moisture content of the grain once decided on the spot or determined in the laboratory and the same will be final. Wherever moisture content of grains in the godown assessment and laboratory assessment differs, higher moisture between these two readings will be adopted for imposing monetary cut for moisture content. As moisture content is decided on the spot, no dispute will be entertained for re-examination of the moisture content at any stage.
