4. TENDER FEE

5. ELIGIBILITY CRITERIA:

- i. The bidder should have overall turnover of minimum Rs.2 Lacs (Rupees two Lacs Only) in last three years i.e. 2016-17, 2017-18 & 2018-19 in supply, installation, testing commissioning and maintenance of entire CCTV system and in support thereof their balance sheets/profit & loss accounts be attached duly certified by their Chartered Accountant
- ii. The bidder should have minimum 3 years of experience of supply ,installation, testing commissioning and maintenance of entire CCTV system in Central Government/State PSU(s) State Government Department/Semi-Govt. Department/PSU/MNC and should submit copies of letter of award in support thereof duly attested for the preceding three years 2016-17, 2017-18 & 2018-19. At least one work order/AMC for CCTV maintenance should pertain to Central Government/State PSU(s) State Government Department/Semi-Govt. Department/State PSU(s) State Government Department/Semi-Govt. Department/State PSU(s) State Government Department/Semi-Govt. Department/State PSU(s) State Government Department/Semi-Govt. - iii. The bidder should not be under a declaration of intelligibility for corrupt or fraudulent Practices or blacklisted by any of the government agencies.
- iv. The bidder should have a fully functional service center with stock of necessary spares for attending to the breakdown calls. Details of service center to be provided.
- v. Offer should be as per tender specifications. Any deviation in the offer will be rejected.
- vi. Bidder has to produce certificate duly ink signed by CA for status whether firm is proprietary/partnership, etc. with proof.
- 6. Bidder should not sub-let /sub-contract the contract for annual maintenance at any time during the contractual period.

 - j. All applicable licenses should be valid on the date of opening of tender and if any of the license is expiring in between the period of contract, then bidder should revalidate the license well within the time under intimation to MMTC, failing which MMTC reserves the right to terminate the contract without any prior notice and shall recover loss, if any from the bidder/contractor.

8. The period of contract shall be for 3 (three) years effective from the date of signing of agreement as per Annexure-D. The same shall be extendable subject to satisfactory

completion of work during contract period/ extended contract period. The decision of the MMTC shall be final and binding on the contractor in this regard.

- **9.** The bid should remain valid for a period of 60 (sixty) days from the date of opening of the **PRICE BID.**
- 10. All pages of the offer must be signed and stamped by the bidder.
- 11. Tenders with any additional conditions/ deviations by the bidder, whatsoever shall be rejected.
- 12. The bidder shall quote the rates in English Language and International numerals. These rates shall be entered in figures as well as in words. In case of difference in rates between words and figures, Rates mentioned in words shall be treated as valid and final. Rates mentioned in Price bid should be exclusive of GST.
- 13. All entries in the tender shall be typed/written in ink. Erasers and over writing are not permitted and may render such tenders liable for rejection.
- 14. The Earnest money may be forfeited in the event of:
 - i) Bidder withdraws its tender during the period of tender's validity.
 - ii) In case of successful bidder, if the bidder fails to accept the order based on his/her offer (bid) within the prescribed time.
 - iii) In case of successful bidder, if the bidder fails to commence the work, as required.
- 15. If the bidder deliberately gives wrong information in tender document, MMTC reserves the right to reject such tender at any stage or to cancel the contract, if awarded and forfeit the Earnest Money/Security deposit/ any other moneys due.
- 16. <u>Bidders are advised to visit MMTC Mumbai sites/locations to inspect the present set-up</u> and acquaint themselves with requirement and quantum of work, facilities available to understand the tender requirement fully before submission of their bids. No claim shall be entertained later on the grounds of lack of knowledge. It is understood that the bidder/ contractor has satisfied itself on the information and knowledge required before tendering. No escalation/extra charges shall be payable/entertained for whatsoever reason during the entire period of contract/agreement.
- 17. The equipment and parts supplied/installed shall be of the latest technology, best quality and high standards. The bidder should enclose the product catalogue supporting the specifications of the equipment/parts being supplied/installed/upgraded/replaced.
- 18. MMTC do not bind itself to accept the lowest or any bid and reserves the right to reject any or all the bidder in full or part, without assigning any reasons thereof.
- 19. The bidder must comply with all terms and conditions contained herein.
- 20. No request will be entertained by MMTC for increase in Price/extra charges due to whatsoever reason for any job specified during the validity of the contract.
- 21. The bidder/contractor shall ensure that the service engineer(s) deployed by it for installing/maintaining the CCTV system behave decently and does not indulge him/herself in any such activities which are unbecoming on the part of a person working in a Government Office.
- 22. The bidder/contractor shall be responsible for any injury caused to persons or things, (fittings/fixtures/furnishings. etc), any damage caused to any property of MMTC etc. which may arise from the operations or neglect of any person of the tenderer/contractor's team or any person engaged by it for any purpose related to the execution of the job.
- 23. The bidder/contractor shall indemnify MMTC and keep MMTC indemnified against all liabilities arising out of its operations in any way under any acts of the Government and also in award of any compensation or damaged consequent upon any claim arising out of above.

- 25. The bidder/contractor shall indemnify MMTC and keep MMTC indemnified against all third-party actions/claims of infringement of patent, trademark or industrial design rights etc. arising from the use of equipment or any part thereof.
- 26. **PAYMENT TERMS:** The payment as agreed shall be released on quarterly basis after verification by MMTC regarding successful/satisfactory completion of all the service calls during the quarter and upon submission of original bill by the contractor. The payment shall be released through E-Payment after necessary deduction of applicable taxes etc.

- The contractor agrees to execute and fulfil Comprehensive Annual Maintenance Contract for CCTV system and parts thereof including upgradation, replacement and repair at 1) MMTC House, C-22, E-Block, Bandra Kurla Complex, Bandra (East), MMTC's office at 2) Sahar Cargo and 3) Seepz Unit, Andheri as per Scope of Work mentioned under General Terms and Conditions of Tender no. MMTC/MUM/SYSTEMS/2019-20/01 DATED 05.07.2019
- 2. In case the jobs entrusted/assigned to the contractor are found not satisfactory or not in accordance with the specifications or specified/samples given by the Management of MMTC,

the contractor shall be liable to change the same and in default whereof the contractor shall compensate to MMTC as per provisions in tender.

- 3. The rate quoted by the contractor in price bid of tender no MMTC/MUM/SYSTEMS/2019-20/01 DATED 05.07.2019 shall be remain valid through the period of contract.
- 4. The Contractor shall submit bills in duplicate on quarterly basis upon completion of the quarter for the work executed as per this contract. MMTC will verify the work, process bill and payment shall be released through e-payment mode as per a/c details provided after deduction of statutory levies / tax, as applicable. MMTC shall have all rights to make adjustment from the bills in respect of the amount due to it from the contractor as per terms contained herein.

- 14. <u>FORCE MAJEURE:</u> If at any time during the existence of this contract either party is unable to perform in whole or in part any obligations under this contract because of war, hostility, military operations, civil commotions, sabotage, quarantine, restrictions, acts of God and acts of governments (including but not restricted to prohibitions of exports and imports) fires, floods, explosions, epidemics, strikes or any other labor trouble, embargoes, then the date of fulfillment of any obligations engagements shall be postponed during the time when such circumstances are operative. Any waiver/Extension of time in respect of the delivery of any installment shall not be deemed to be waiver/extension of time in respect of the remaining deliveries.

"If operation of such circumstances exceed three months, either party will have the right to refuse further performance of the contract in which case neither party shall have the right to claim eventual damages". The party which is unable to fulfill its obligations under the present contract must within 15days of occurrence of any of the causes mentioned in this clause shall inform the other party of the existence or termination of the circumstances preventing the performance of the agreement notwithstanding this, provisions relating to indemnity, confidentiality survive termination of the agreement.
